

2pc Truck Running Board LED Light Kit



Test for Functionality

1. Test the 2pc Truck Running Board LED Light Kit for proper functionality.
 - Connect the black ground wire to the negative battery terminal.
 - Test running light function by temporarily connecting the yellow wire to the vehicle's positive battery terminal.
 - Test turn signal function by temporarily connecting the orange wire to the vehicle's positive battery terminal.
 - Test courtesy light function by temporarily connecting the white wire to the vehicle's positive battery terminal.
 - Remove the 2pc Truck Running Board LED Light Kit from power once testing is complete.

Mounting Location

2. Determine the mounting location of the 2pc Truck Running Board LED Light Strips such as; the pinch weld on the lower side of the rocker panel, the rocker panel, or the running board. The 2pc Truck Running Board LED Light Strips are flexible and can be contoured to fit uneven or curved surfaces. **(Optional) Raise the vehicle.**



Mounting

3. Thoroughly clean the mounting location surface with an alcohol prep pad.

TECH TIP : (Optional) Use Adhesion Promoter on a clean, dry mounting location to allow for the strongest bond. Available at www.LEDGlow.com

4. Mount the driver and passenger side Truck Running Board LED Light Strips.

- Ensure all wires on the 2pc Truck Running Board LED Light Strips are facing the front of the vehicle.
- Remove the double sided tape backing in sections while firmly pressing the Truck Running Board LED Light Strips to the mounting location simultaneously.

TECH TIP : It is not recommended to remove all double sided tape backing at once.



5. Use the supplied mounting brackets and screws as needed for extra mounting security.

- Line up the mounting bracket overtop of the Truck Running Board LED Light Strips and mark the intended screw locations.
- Pre-Drill pilot holes with a 3/32" drill bit.
- Using the self-tapping screws, screw the mounting brackets into place securing the Truck Running Board LED Light Strips.

6. Locate a grommet, preferably on the floor board. Route all wires into the cab of the vehicle keeping clear of moving parts or extreme heat.

7. Remove interior paneling as necessary for access to the wires.

- **Yellow Wires - Amber Running Lights**
- **Orange Wires - Amber Turn Signals**
- **White Wires - White Courtesy Lights**
- **Black Wires - Ground**






- o Determine the appropriate power source for each lighting function on the vehicle using a test light or multimeter.
- o When Connecting the wires to power, use proper technique when splicing, soldering, using wire taps, or the included Butt Splice Connectors.

Connecting To Power

8. Connect the 2pc Truck Running Board LED Light Kit's **Yellow Wires - Dim Amber Running Lights (Side Marker Amber LED ON with Headlights)** to a 12V power source according to your preference as listed below.




- Locate a 12V Switched Headlight Source on the vehicle.
 - o Example: vehicle headlight switch, running light wire, or a source which receives 12V power ONLY when the headlights are on.
 - o Some vehicles feature a 12V switched headlight fuse located in the vehicle's fuse panel which can be tapped into using an Expandable Circuit available at LEDGlow.com
- Connect the 2pc Truck Running Board LED Light Kit's **Orange Wires - Bright Amber Turn Signals (Side Marker Amber LED ON with Turn Signal and Hazard Lights)** to a 12V power source according to your preference as listed below.


- Locate the vehicle's Driver and Passenger Side 12V Switched Turn Signal Source. Connect the Orange Wires individually from each strip accordingly.
 - Example; vehicle turn signal switch, front turn signal wires, or a source that receives 12V power ONLY when turn signals are on.
- Connect the 2pc Truck Running Board LED Light Kit's **White Wires - White Courtesy LED (Side Amber White LED ON with Dome Light)** to the vehicle's Dome Light Wire.



- Use a Service Repair Manual to locate the vehicle's Dome Light Wire.
- Test the Dome Light Wire using a test light or multimeter to verify the circuit type.
- Connect the 2pc Truck Running Board LED Light Kit's **Black Wires - Ground Source**.

⚠WARNING : On some applications it may be required to add a relay kit in order for the light to operate with the dome light. Some vehicles have a ground side controlled system that has constant power to the light and will then switch the ground on and off. This can be tested with a test light or multimeter. There will be power on both sides of the bulb when the light is off. As soon as the light turns on there will be power on one side and a ground source on the other.

- **If relay kit is needed:** Install an SPDT 12V style automotive relay (AE-001-1) and harness, which can be purchased at an automotive parts store. Connect pins 86 (white wire) and 30 (blue wire) together and connect to a constant power source. Connect pin 87 (yellow wire) to the white wires on the light kit. Connect pin 85 (black wire) to the vehicle's ground switching wire. Connect the light kits black wires to clean ground source. Pin 87a (red wire) is not used. (Harness wire colors may vary.)
